### *FIERA MILANO: INFORMATION ON PURCHASE OF TREASURY SHARES*

**Milan, 26 July 2016.** Fiera Milano S.p.A. announces that, in the period from 18 July 2016 to 25 July 2016 inclusive, it has acquired on the Italian Stock Exchange (Mercato Telematico Azionario) no. 26,500 of its treasury shares at an average unit price of Euro 1.60514, for a total value of Euro 42,536.30. These purchases have been made as part of the share buy-back plan, the initiation of which was communicated to the market on 24 June 2016, and in implementation of the resolution approved by the Shareholders' Meeting of 28 April 2016.
